(4.2) FRTIB did not have any filers subject to the late filing fee during the period under review. (4.8) Eighteen public reports were required to be filed by FRTIB employees in 2016. Seven of the reports were certified more than 60 days after being filed. Four of these reports were certified only 11 days or fewer beyond the 60-day review and certification period because ethics officials were seeking additional information from the filers. OGE considers these reports to be certified timely. However, the remaining 3 reports were certified between 30 and 123 days beyond the 60-day review and certification period. Although ethics officials were also pursuing additional information from these three filers in order to certify their reports, because of the extended period of time between filing and certification, OGE does not consider these reports to have been certified timely. (4.9-4.11) FRTIB does not have PAS officials.

<p>(5.3) FRTIB does not have an alternative confidential financial disclosure system.</p> <p>(5.5) Seven of the 20 new entrants reports OGE examined were filed late. Ethics officials explained that six of these filers entered into covered positions in 2015 and should have filed their reports in 2015; however, they filed their reports in early 2016. Ethics officials further explained that the ethics office was not timely notified when the employees were assigned duties that would require them to file a confidential financial disclosure report (e.g., when employees began serving on a source selection panel for a contract). Therefore, the filers were not timely notified to file their reports.</p> <p>Ethics officials indicated that they have since instituted a process requiring that contracting officers notify the Office of General Counsel when they form a new source selection panel. Consequently, ethics officials can conduct a conflict of interest review for any panel member with a current OGE Form 450 on file or send a filing request to a panel member who had not filed an OGE Form 450 previously during the year. This process has been included in the FRTIB financial disclosure procedures.</p> <p>OGE notes that of the remaining 14 new entrant reports that were properly filed in 2016 after the new procedures were implemented, all but one were filed timely. (The remaining new entrant report was filed only five days after it was due.) Because the identification of new entrant confidential filers improved in 2016, OGE is not issuing a recommendation for improvement.</p>
